CCWI data used by State EPA

In 2005, CCWI followed up on the previous year's submittal of citizen monitoring data to the State 303d list of impaired waterbodies. CCWI data was used to make water quality determinations in over 10 places! This was one of the first times that citizen monitoring data had been used in this way. Thank you to all citizen monitors for the great work you are doing!

Climate Change promoted at Bay Area Air District

CCWI, with the Climate Protection Campaign, completed a study on the Integration of Air Quality and Climate Protection. On June 1, 2005, after 3 years of local advocacy from CCWI, the Bay Area Air Quality Management District created a new Climate Protection Program. In 2006, CCWI will continue to promote regional climate protection.

The Lower Russian River Water Quality Monitoring Project

CCWI hosted several citizen monitor recruitment and training workshops, produced and distributed fact sheets from data collected in Dutch Bill Creek, Monte Rio, and the Lower Russian River to the coast to hundreds of residents in those watersheds. Community Clean Water Institute

Community Clean Water Institute is dedicated to promoting and protecting clean water and public health by identifying water pollution, advocating for sound water policies, and providing information to the public.


CCWI's Citizen Monitoring Program: CCWI Citizen Monitors use monitoring equipment, collect data, learn about their watershed, help pinpoint pollution sources, and identify widespread problems on over 17 creeks and streams. To become a citizen monitor, contact the CCWI office. CCWI continued monitoring on the Lower Russian River, hosted several training workshops, and distributed factsheets with best management practices to over 700 homes. In 2005, CCWI followed up on the previous year's submittal of citizen monitoring data to the State 303d list of impaired waterbodies. CCWI data was used to make water quality determinations in over 10 places! This was one of the first times that citizen monitoring data was used in this manner.

Water and Climate Program: CCWI and the Climate Protection Campaign, completed a report on climate change for the Bay Area Air Quality Management District, which created a new Climate Protection Program. This is the first time an Air District in California is addressing climate change issues. The Sonoma County Water Agency's new energy policy calls for GHG reductions. In Spring 2005 CCWI facilitated a workshop for local govt. featuring an appearance by Robert F. Kennedy Jr.

Environmental Education: CCWI has facilitated two year-long environmental studies programs at Stuart School, a Santa Rosa K-8 school. Students participated in water quality monitoring on Santa Rosa Creek, stream clean ups, and restoration.

Water Rights, Privatization and Public Trust Program:

CCWI co-sponsored "Dinner to Defend the Commons" on December 10, 2005 featuring speaker Jonathan Rowe of the Tomales Bay Institute. The Commons is the public trust, including our public schools, wetlands, national parks, forests, air, water, Social Security, Medicare, libraries, and more.

Fortuna: CCWI intern Jon Mooney, a Master's student at HSU, is working with the Redwood Coast Energy Authority to identify energy savings from Fortuna's City operations, and upgraded Wastewater Treatment plant. The report features quantification of Fortuna's greenhouse gas emissions and suggestions for future actions.
